## Review of coercion and controlling behaviour (CCB) offence

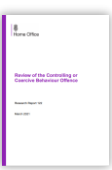

The Home Office has reviewed the coercion and controlling behaviour (CCB) offence, to understand how it has been used since its introduction in 2015. The review, published in March 2021, found that the number of coercion and controlling behaviour offences recorded by police has increased from 4,246 in 2016/17 to 24,856 in 2019/20. In 2019 1,112 people were prosecuted for the offence.

A key message of the review is that despite the increase in reports, coercion and controlling behaviour is still likely to be very underreported and under recorded.

The Crime Survey for England and Wales data on domestic violence suggests that only one in five cases is reported and the review finds it likely that CCB is unreported by a similar amount.



The review finds that there is a need to understand, identify and evidence coercion and controlling behaviour.

The guidance focuses on accessibility and communication, and includes things to consider before, during, and after a visit.
